WAIVER AND RELEASE OF LIABILITY

In consideration for the rights and privileges associated with participation in the Talmud Torah 3 on 3 Basketball Tournament, I acknowledge and agree to be bound by the following:

- 1. IDENTIFICATION OF RISKS. I understand that participation in any basketball activity, including tournament play, is dangerous, involves risk of serious injury, death, and other losses both to person and property. I understand that these injuries and losses might result not only from my action, but the actions, inactions or negligence of others.
2. ASSUMPTION OF THE RISK. I agree that I am responsible for my safety while participating in the Talmud Torah 3 on 3 Basketball Tournament and that such responsibility includes participating only when I am physically and mentally prepared to participate safely. I assume all risks associated with responsibility for any injury or loss connected with my participation in the tournament. I further agree that at any point, if I feel endangered either by my own actions or those of others, I am free to withdraw from the tournament and will do so of my own free will.
3. WAIVER. Aware of the risks and willing to assume them, I hereby waive, release, and hold harmless the Talmud Torah of St. Paul and its affiliates, subsidiaries, officers, directors, employees, agents, coaches, doctors, officials, event organizers, volunteers, or sponsors (Released Parties) from all claims, by me for any liability, injury, known or unknown, loss or damage in any way connected with my participation in the Tournament. I intend for this waiver and release to also apply to any relatives, personal representatives, heirs, beneficiaries, next of kin or assigns who might pursue any legal action or claim on my behalf.
4. APPLICABLE LAW. This Waiver and Release is formed under and is to be interpreted consistent with the laws of the State of Minnesota.
5. INSURANCE. I currently have and agree to maintain throughout the time that I participate valid and sufficient medical insurance. I understand that this is my sole responsibility and I release all persons and entities from providing this coverage for me.
6. AUTHORIZATION FOR PHOTO USE. I authorize Talmud Torah of St. Paul to use solely for publicity purposes in print or on the Talmud Torah website, any image of me and/or my child.
